

The Northern Territory Police have the power to take out a domestic violence order on the spot to make sure you are safe in urgent situations.

If you or someone you know is at risk of serious harm call the police now on 000. If it is not urgent, call the police on **131 444**.

The Domestic Violence Legal Service (DVLS) can help with:

- free, confidential legal advice about your options
- legal help with:
 - applying for a domestic violence order (DVO)
 - police DVOs
 - changing a DVO
 - extending a DVO
 - removing a DVO.
- duty lawyer service at the Darwin Local Court
- community legal education
- referrals to other legal and support services.

DVLS also has a worker who supports women and children with safety and wellbeing.

We have regular, free advice clinics in Darwin and Palmerston.

We can arrange advice by phone and an interpreter.

You can also call the **Translating and Interpreting Service** on **131 450** and ask them to connect to the Domestic Violence Legal Service on 8999 7977.
